#### Example member ID cards

## For Kelsey-Seybold Individual Exchange plans in Houston

*Applies to these counties only: Brazoria, Fort Bend, Galveston, Harris and Montgomery*

In 2024, we're offering new fully capitated Kelsey-Seybold Individual Exchange plans in the Houston area. The narrow network will include Kelsey-Seybold clinics in the counties of Brazoria, Fort Bend, Galveston, Harris and Montgomery.



Members who select these plans will be assigned to a Kelsey-Seybold Clinic PCP to help them manage their care and receive custom member ID cards.


**If you're not a participating provider in the Kelsey-Seybold network and a member presents with this ID card, please redirect them to Kelsey-Seybold clinic.**



## How to identify a member with a Kelsey-Seybold Individual Exchange plan

- 1 Plan name and Kelsey-Seybold Clinic logo
- 2 Payer ID – claims must be submitted to Payer ID KELSE
- 3 PCP Required indicator – all members will be auto-assigned to Kelsey-Seybold Clinic
- 4 Referrals Required indicator (if applicable)
- 5 Kelsey-Seybold appointment scheduling number

## Kelsey-Seybold Provider Portal

Providers participating in the Kelsey-Seybold network can use the UnitedHealthcare Provider Portal or the Kelsey-Seybold Provider portal to access eligibility and benefits, claims and prior authorization information.

### Referrals

Referrals aren't needed for members to see a Kelsey-Seybold clinic specialist. However, a referral is required for members to see a non-Kelsey-Seybold clinic specialist. To request a referral, contact a participating specialist outside of the Kelsey-Seybold clinic.
